Dear IAEM-USA Members,

Nominations are only being accepted **until tomorrow** for the positions of **IAEM-USA Second Vice President** and **IAEM-USA Secretary**. Candidates must submit their credentials by **5:00 p.m. Eastern time, on Thursday, July 2, 2020**, to IAEM Headquarters via email to [info@iaem.com](mailto:info@iaem.com), to be reviewed by the IAEM-USA Nominations & Credentials Committee.

### **Submit IAEM-USA Officer Credentials**

To be placed on the ballot, candidates must submit:

- a letter stating candidacy;
- a letter of permission from the candidate's immediate supervisor supporting the time and travel necessary to fulfill duties of office;
- a brief resume; and
- confirmation that they have been an IAEM-USA Individual member for at least two consecutive years immediately prior to seeking office.

### **Officer Candidate Eligibility**

**Individual members** are eligible to hold national office, provided they have been an Individual member for at least two consecutive years immediately prior to seeking office, **and** have served as a regional or national officer, national committee chair, or active national committee member for two consecutive years. All candidate campaign articles will be published in the **August 2020** issue of the IAEM Bulletin. The articles also will be posted on the voting web page.

- As noted above, you **must** submit your **credentials** to IAEM Headquarters via email to [info@iaem.com](mailto:info@iaem.com) no later than **5:00 p.m. Eastern time, Thursday, July 2, 2020**.
- Your **campaign article** (no more than 500 words), contact information, and photo **must** be emailed to IAEM Bulletin Editor Karen Thompson no later than **5:00 p.m. Eastern time, Friday, July 17, 2020**. Email articles in Word or text format to [Thompson@iaem.com](mailto:Thompson@iaem.com). A photo that is embedded in a Word document may not be sufficiently high resolution to use in the Bulletin. You should attach your photo to your email as an image file (jpg, png, tif format).

The online voting period will be from **Monday, August 3, 2020, 9:00 a.m. Eastern time** through **Monday, August 31, 2019, 5:00 p.m. Eastern time**.
