Submit Regional Officer or State Representative Credentials

To be placed on the ballot, candidates must submit **all** of the following to Rcampbell@iaem.com by **5:00 p.m. Eastern time, Thursday, July 2, 2020**.

- **A candidate statement in Word or text format:** A candidate statement should tell the regional members why you are qualified to be an officer (related experience whether work or non-work related) and what you hope to accomplish during your term of office if elected.
- **A photo** provided as an image attachment to the candidate's nomination email (such as PNG, JPG, TIF, GIF).

Region 10 Officer or State Representative Candidate Eligibility

To be elected or appointed to an office, a member shall meet the following requirements:

- Be an Individual IAEM-USA member in good standing.
- In order to be placed on the ballot for election, the person must meet the qualifications as established in the [IAEM-USA Administrative Policies & Procedures](#).

- A member cannot hold and cannot run for more than one office at a time.

Voting Period

The online voting period will be from **Monday, August 1, 2020, 9:00 a.m. Eastern time** through **Monday, August 31, 2020, 5:00 p.m. Eastern time**.
