# **Submit Regional Officer Credentials**

To be placed on the ballot, candidates must submit **all** of the following to <u>Rcampbell@iaem.com</u> by **5:00 p.m. Eastern time, Thursday, July 2, 2020**:

- A candidate statement in Word or text format: A candidate statement should tell regional members why you are qualified to be an officer (related experience whether work or non-work related) and what you hope to accomplish during your term of office if elected.
- A photo provided as an image attachment to the candidate's nomination email (such as jpg, png, tif).

# **Regional Officer Candidate Eligibility**

To be elected or appointed to an office, a member shall meet the following requirements:

- Have been an Individual IAEM-USA member for a minimum of two consecutive years prior to seeking office.
- In order to be placed on the ballot for election to office, the candidate must meet the qualifications as
  established in the <u>IAEM-USA Administrative Policies & Procedures</u>. A member cannot hold and
  cannot run for more than one office at a time.

The online voting period will be from Monday, Aug. 3, 2020, 9:00 a.m. Eastern time through Monday, Aug. 31, 2019, 5:00 p.m. Eastern time.
