This year IAEM-USA regional elections are being held during the same time frame as the IAEM-USA Council officers' election, and they are being administered by IAEM staff, as based on the direction of the IAEM-USA Board. Nominations are now being accepted for the following regional officer positions:

- IAEM-USA Region 4 President-Elect
- IAEM-USA Region 4 Secretary-Treasurer

Candidates must submit their credentials by **5:00 p.m. Eastern time, on Thursday, July 2, 2020**, to Rebecca Campbell, IAEM elections facilitator, at [Rcampbell@iaem.com](mailto:Rcampbell@iaem.com).

**Submit Regional Officer Credentials** To be placed on the ballot, candidates must submit **all** of the following to [Rcampbell@iaem.com](mailto:Rcampbell@iaem.com) by **5:00 p.m. Eastern time, Thursday, July 2, 2020**.

- **A candidate statement in Word or text format:** A candidate statement should tell the regional members why you are qualified to be an officer (related experience whether work or non-work related) and what you hope to accomplish during your term of office if elected.
- Region 4 officer candidates must have served as a committee chair or active committee member for two consecutive years. State how you meet that criteria.
- **A photo** provided as an image attachment to the candidate's nomination email (such as jpg, png, tif).

#### **Regional Officer Candidate Eligibility**

To be elected or appointed to an office, a member shall meet the following requirements:

- Have been an Individual IAEM-USA member for a minimum of two consecutive years prior to seeking office.
- Have served as a committee chair, or been an active committee member for two consecutive years.
- In order to be placed on the ballot for election to office, the person must meet the qualifications as established in the [IAEM-USA Administrative Policies & Procedures](#).
- A member cannot hold and cannot run for more than one office at a time.

#### **Voting Period**

The online voting period will be from **Monday, August 3, 2020, 9:00 a.m. Eastern time** through **Monday, August 31, 2020, 5:00 p.m. Eastern time**.
