

IAEM Student Advocate of the Year 2023

The IAEM Student Advocate of the Year Award recognizes an individual (IAEM member or non-member) or organization that has assisted, promoted, or supported students in their activities in the field of emergency management and higher education. Examples could be individuals who ensured student involvement in emergency management programs or someone who guides students towards involvement in IAEM, their professional degrees or attainment of the CEM/AEM designation.

Since this award combines elements of the former Student Ally of the Year and Student Chapter Advisor of the Year, this award may recognize an individual or organization who has made great strides in assisting students to further their education and career goals in emergency management.

Who is eligible?

- A nominee for Student Advocate of the Year must not have received an award in a previous year.
- The nominee does not have to be a member of the IAEM.
- Self-nominations are not accepted.
- The award considers contributions and achievements during the previous school calendar year
- The award recipient does not need to be present at the IAEM Annual Conference to be selected, although the award recipient is strongly encouraged to participate in the conference.

Award Criteria (what an entry will be judged on)

- (Weight: 40%) **Student advisement:** Describe how the nominee assisted, promoted, or supported students in the field of emergency management and higher education. This could also include how the nominee supports an IAEM student chapter.
- (Weight: 43%) **Engagement to ensure student involvement:** Demonstrate activities that engage student involvement in emergency management. Provide specifics on engagement activities. This may include starting a new student chapter, significantly enhancing a chapter's growth and service
- (Weight 20%) **Guidance:** Describes academic and professional guidance the nominee has provided to students.

Completing the Official Award Entry/Nomination

- **Method:** An entry **must** be submitted in English on the official IAEM awards portal, available on the Membership Dashboard after logging in on the iaem.org website. People who are not members of the IAEM who wish to submit an entry must register as a Guest on the IAEM website to gain access to the awards entry portal.

- **Remain within specified limits:** Some entry details have limits on the number of words. Information that exceeds the word limit will be truncated and excess words will not be visible to judges. Be concise!
- **Complete all entry details:** Fill in each blank on the award entry portal. Incomplete information will cause the entry to be rejected.
- **Deadline:** Entry must be submitted no later than the submission deadline announced by the IAEM via email and on its website. Late entries will not be considered.
- **Supporting Materials:** No supporting materials are required for this award, such as recommendations or letters of support, are requested.

Judging Process

The judging panel is assigned by the Awards and Recognition Committee Chair or delegate.

All award entries will be judged through an unbiased selection process. Judges will review entries ensuring that the nomination complies with the format and content requirements explained above and that all above-referenced criteria are explained in a thoughtful yet concise manner.

Only written documentation via entries and uploads on the awards portal will be reviewed. Incomplete entry forms will not be considered.

Judges who have a conflict-of-interest (as defined in the *IAEM Code of Conduct*) will recuse themselves from judging an entry with which there is a conflict.

The judging panel will recommend one selected recipient of this award to the IAEM-USA Awards and Recognition Committee for a final decision. The IAEM-USA Board of Directors, IAEM CEO, or other Association leadership does not review, approve, or referee decisions of the IAEM Awards & Recognition Committee.

Announcement of Award Results

Once the USA Awards and Recognition Committee confirms the selection of who will receive this award, IAEM Headquarters will notify the recipient, the nominator, the IAEM Region of the recipient's jurisdiction, and appropriate Caucus(es). Nominators who submitted an entry that was not selected will also be notified.
