Introduction

My name is Rodney Andreasen, and I am submitting my application for IAEM-USA Region 4 Florida State Representative position. I have been a Certified Emergency Manager (CEM) for nearly 15 years with the International Association of Emergency Managers (IAEM). I was an Emergency Management Director for 20 years, from 2001-2020, in the state of Florida and served 21 years, 1978-1999, in the United States Air Force prior to that in various specialties and assignments. I currently serve as the Vice Chair of the Faith Based Caucus for IAEM and have done so for approximately three years.

Below you will find the key qualities and competencies that I believe align perfectly with the demands of the critical position.

Proven Leadership in Crisis Situations

A defining quality of an effective emergency manager is the ability to lead under pressure and provide guidance to agencies and personnel in response to numerous threats. My background includes extensive experience managing and responding to high-pressure scenarios, ensuring that objectives are met efficiently and effectively resulting in the protection of life and property. As a local emergency manager, we were tasked to be on 24/7 call and required to respond to almost all incidents that may exceed a single individual response.

Starting with the terrorist attacks during 9/11, I was a member of the Florida Regional Domestic Security Task Force (RDSTF) organization providing advice as an emergency manager assisting in the preparation for possible impacts. Before retiring, I became the Co-Chair of the Prevention and Awareness group for the RDSTF.

During my time as the emergency manager, I prepared, directed and responded to numerous incidents that impacted my community. In 2004, I directed preparations for Hurricane Ivan that eventually struck Pensacola, Fl. However, because of the size of the storm, impacts from the system were felt in my local community. As we had predicted, tornadoes spun off the system and would eventually impact the county. We had previously warned the residents of this fact, and it was proved correct in issuing the orders that resulted in no loss of life. The tornado that spun off the storm killed four people in the county south of our location; however, the tornado caused more property damage to our county as a result. The tornado heavily damaged two trailer parks, two housing subdivisions as well as the local Federal Prison. Additionally, a facility that the emergency management office was urged to use, and was refused by the Director, as a hurricane shelter was destroyed by a direct hit from the tornado. It was determined that

most people, if they had been in it, would not have survived. The building was not a certified facility for such use.

Since 2001, the Emergency Management Director had warned of the possibility of a large category storm, Category 2-3, impacting the area and that the county must prepare for that eventuality. Because the county was located 35 miles from the coast, local residents, and leadership, felt this would not happen as there was too much land mass to interfere with the storm. Regardless, as the Emergency Manager, I continued to warn and plan for just such an event. On 10 Oct 2018, Hurricane Michael slammed into the Gulf Coast not as Category 2 or 3, but a Category 5 storm; our county was hit with Category 4 Because of prior efforts and planning, the EOC was able to maintain impacts. communication and direct operations through much of the storm. The challenge of providing directions, as well as making decisions, for 50000 citizens' lives, has provided me, I feel, with the necessary skills to address the issues that will arise as a representative of IAEM for the state of Florida. During my time as the Emergency Management Director, I responded to over 15 large and small train derailments, numerous flooding events and various other incidents that included flooding, aircraft crashes and HAZMAT accidents and releases.

Additionally, with recent events in the Middle East, as well as the increased threat to the local communities in the state from terrorism, I feel my previous military background and education can address those threats and challenges as well. While in the military, I was the Non-Commissioned Officer In Charge (NCOIC) of a small unit anti-terrorism program providing training, as well as classified and non-classified briefings, for unit personnel. This aspect provided me with a unique view of anti-terrorism information, functions and protective measures. Additionally, in 2010, I was selected to attend the Naval Postgraduate School Center for Homeland Security and Defense (CHDS) graduating with my third masters' degree in Homeland Security and Defense. These abilities enable me to anticipate challenges and prepare effective strategies that minimize risk and maximize safety in the event of an incident.
