#### Status of CEM®/AEM Program

Since the Certified Emergency Manager® Program was introduced in 1993, 10,807 have enrolled to pursue the CEM® designation. Last year, there were 6,808. Of these, by May 31, 2010, 1,480 had been awarded the Certified Emergency Manager® (CEM®) credential, and 69 had been awarded the Associate Emergency Manager (AEM) credential. About 275 candidates await review or are in the application process (candidates have made a submission, and staff or commissioners have requested additional information). Only 32% of those pursuing the credential are IAEM members. IAEM membership is not required to participate in the CEM® Program. IAEM members realize a fee discount, since the general fund subsidizes in part the program operations.



· Beginning Jan. 1, 2010, all U.S. candidates were required to have a four-year baccalaureate degree from an accredited institution to obtain a CEM® designation.





 Up until Dec. 31, 2011, non-U.S. candidates may substitute two years of additional experience in a disaster/emergency management position for each year of college credit lacking (based on 30 credits per academic year) or eight years of disaster/emergency management experience or a total of 11 years of full-time comprehensive emergency management experience for no recorded college credit. After this date, all CEM® candidates must have a four-year college degree.

#### **Looking Ahead**

In 2011, the CEM® application is slated to be made available as a Web-based application, which will ease the application process for the applicant and will make the completed, printed application more uniform and more consistent for CEM® Commission review. The CEM®/AEM Prep Course will be offered several times in webinar format to make it more accessible to potential participants and will also continue to be available in the on-demand format.






## **Membership Growth**

IAEM's final roster for 2009-2010 included 5,305 paying members, an increase of 439 members over 2008-2009 (8.3% membership growth) as of May 31, 2010.

#### Highlights: (as of May 31, 2010)

- The IAEM-Global membership includes Individual members (3,702 members), Affiliate members (61 members), and Student members (1,542 members) for a total 5,305 members.
- The largest council is the IAEM-USA Council, with 2,911 Individual members (55%). The second largest council is the IAEM Student Council with 1,542 members (29%), while the third largest council is the IAEM-Canada Council with 225 members (4%).



• In the IAEM-USA Council, the Student Region is the largest USA region (1,401 members), followed by Region 4, Southeast USA (827 members) and Region 3, Mid-Atlantic USA (812

members). Region 6, Midwest USA is the fourth largest USA region (672 members), with Region 9, West Coast coming in as the fifth largest USA region (479 members).

## **IAEM Council Reports**

#### **IAEM-Asia**

- The IAEM-Asia Council covers 2.5 billion people in 27 countries speaking 2,000 languages. As of May 31, 2010, the council had just under 100 members, with national representatives in 13 countries.
- · The council focuses its efforts on promoting professional networking, emergency management training and CEM® certification. Networking events for members and non-members in Indonesia, Philippines and Malaysia helped those efforts.
- IAEM Taiwan National Representative Mr. Gu Tswen Juh became the first individual in Asia to earn CEM® certification since the Council was formed. He joins Dr. Ha Kvoo Man in Korea as the first CEM® holders in Asia.
- IAEM-Asia's major activity this year was organizing the Asia-Oceania 2010 Resilience Conference for October 2010 in Singapore. We contracted a conference hotel, selected 16 presenters, identified sponsors/ exhibitors and supporting organizations, built a conference website, and initiated online marketing to potential attendees. French bank BNP Paribas is the major sponsor. The IAEM-Global Board will hold its first meeting outside the United States at AOR 2010.
- In addition to its IAEM-Asia website, the council this year launched a Facebook page, Twitter feed, LinkedIn group and YouTube® channel for AOR 2010. A complimentary quarterly e-newsletter is sent to all who sign up at the IAEM-Asia website; the mailing list is now more than 1,000. The council applied to Singapore's Registry of Societies (RoS) to become an authorized non-profit professional association.

Canada has strived to improve its outreach to members, while finding opportunities to engage with partner agencies such as the Canadian Emergency Management College in discussions on how we can promote the profession in Canada as well as provide standard education and training opportunities.

- The IAEM-Canada 2010 AGM, held in Banff, Alberta, in association with Disaster Forum, was a tremendous success. The council is now working towards its 2011 AGM in Atlantic Canada.
- The IAFM-Canada Board assessed. the needs of council members via survey, improved communication to members, developed a strategic plan for 2009-2011, selected a CEM® Commissioner, began planning the foundation of an IAEM-Canada CEM® Commission, ratified Student Region Bylaws, and explored the potential for the council's first Provincial Region in Alberta.
- · The Training, Education and **Professional Development** Committee updated terms of reference, conference list and training; shared pandemic information; sent a training needs survey to members; and arranged for the CEM®/AEM Exam to be offered during the AGM.

- The Marketing and Membership Committee marketing initiatives included a new membership brochure, trade show banners and membership pins. The committee is developing a committee strategic plan, is engaging in website redevelopment, and is involved in discussions about building a virtual library focusing on emergency management.

- During the fiscal year, IAEM-Europa saw the birth of IAEM-Italy as a new region within the council. In addition, IAEM-Europa created its second student chapter at Zilina University. The council leadership will support the new region and new student chapter as they continue to grow.
- With work ongoing to develop student chapters in Spain and Belgium, the structure for the future of the IAEM Europa Council is taking shape.
- · The council held a small event alongside InterSchutz 2010, and new CEM®s will emerge from that. Council leadership is focusing on plans for launching EMEC 2011 alongside InterAirport in Munich, Germany, Oct. 11-13, 2011.
- · The council leaders have worked hard to build a strong administrative structure, but language difficulties, borders and distances need to be overcome to make real headway. The council's national representatives and work group members have represented IAEM-Europa and the association well, and council membership continues to grow.
- IAEM-Europa President Arthur Rabjohn, CEM (Past IAEM-Global Chairman, 2008-2009) noted, "This is my last Annual Council Report as

President of Europa, and I want to take this opportunity to thank all of my fellow IAEM-Europa Board members for their support and efforts to get us to where we are today. For me, the last 10 years has been a labor of love for this association and our profession. I am proud to have played a part in developing a truly international association for our profession and leading the development of this council."

- The IAEM International Council continues to support IAEM growth and activities in Brazil, China, the Caribbean, Mexico, the Middle East and Africa.
- Middle East: The council is in the process of appointing new national representatives in Qatar and United Arab Emirates. Abu Dhabi's Center of Excellence for Business Continuity is currently considering partnership with IAEM to drive EM growth in the Arab World and the Middle East.
- West Africa: IAEM members in Nigeria are working toward setting up a legal entity to serve in the coordination of IAEM activities in West Africa. Membership has floundered a bit in the last year; however, the hope is that IAEM representatives and advisors will continue to drum up more support for more members to join to enable them to form a council for Africa or Nigeria alone.
- South Africa: Through a suggestion from IAEM-Asia, a new contact was indentified that could serve as a partner organization. SRK Consulting is considering a partnership with IAEM to facilitate growth within the Southern Africa Development Authority (SADC).
- AFCOM Collaboration: The council is working with Africa Command (AFCOM), a unit of the U.S. military, to develop new partnerships in East Africa and Central Africa in order to extend IAEM membership and opportunities for growth.
- South America: The second annual Expo Emergencia 2010 will be

held this summer in Rio de Janeiro, Brazil. Clay Tyeryar, MAM, CAE, IAEM International Staff Officer, will represent the International Council at this event as he did last year, taking the opportunity to expand outreach efforts in South America.

Oceania looks forward to presenting its first awards at Asia Oceania Resilience 2010, celebrating the formation of the Oceania-Asia CEM® Commission, and working towards hosting Asia Oceania Resilience 2011.

- During 2009-2010, 67 IAEM-USA members were trained to be Emergency Management Accreditation Program assessors.
- IAEM-USA Past President Russ Decker, CEM, IAEM-USA Government Affairs Chair Randy Duncan, CEM, IAEM-USA Executive Director Elizabeth B. Armstrong, MAM, CAE, and IAEM-USA Policy Advisor Martha Braddock met with President-Elect Barack Obama's transition team in December 2008 to discuss IAEM-USA requests for consideration.
- Through the work of the IAEM-USA Uniformed Services Caucus, chaired by COL Robert L. Ditch (USAF-Ret.), CEM, IAEM-USA was able to obtain unprecedented support from the U.S. Veterans Administration for the use of U.S. Veterans GI Bill benefits to pay for CEM® application and testing.
- The all-hazards message of IAEM-USA members is being heard more clearly, thanks to the hard work of the member volunteers who make it all happen. - The IAEM 2010 Annual Conference will introduce several new offerings, including a significantly improved Welcoming Reception, with food and entertainment highlighting The Best of Texas; Rapid Fire Talks (fiveminute presentations by members of the audience): and Logo Day (to encourage networking among conference attendees).

#### **IAEM-USA Government Affairs** Committee

· Interacting with Congress, senior FEMA leadership, other administration officials, and providing input on a wide variety of policy initiatives continued to be the focus of the IAEM-USA Government Affairs Committee. The committee was led by Chair Randall C. Duncan, MPA. CEM, and Vice Chair Russell Decker, CEM. Martha Braddock, IAEM-USA Policy Advisor, supported the committee's activities. The voice of local U.S. emergency managers continues to be heard clearly and loudly in the halls of Congress and the headquarters of FEMA, with the constant support of the IAEM-USA Board of Directors and membership. The advocacy of state and local emergency management issues

- continues to be a top priority for IAEM-USA members.
- The committee has created many opportunities to engage with key members of the Administration and the Congress, and has had success in its legislative efforts. The strong support of IAEM-USA members and members of the state associations of local emergency managers remains vital. Continued outreach by local emergency managers to their local U.S. Representatives, Senators and their staffs throughout the year is critical to building an understanding with our legislators of what local emergency managers do and why our issues are important back home.
- Some of this year's highlights of Congressional action are:
  - Emergency Management Performance Grants (EMPG).
    - We continue to emphasize the importance of building emergency management capacity at the state and local levels and the importance of increasing funding for EMPG. We have achieved successes in increasing the funding, maintaining the all-hazards nature of the program, and retaining it as a separate account.
    - > For FY 2011, the President requested \$345 million. Both the Senate Appropriations Committee on July 15, 2010, and the House Appropriations Subcommittee on Homeland Security on June 24, 2010, included the \$345 million and rejected the Administration request to combine EMPG into an account with other programs. At the time of writing, the funding for DHS was to be included in a Continuing Resolution, and the Appropriations bill for the Department of Homeland Security was expected to be completed after the November 2010 elections. It has been a difficult budget year, but support for EMPG has remained strong. Sen. Roberts (R-KS) and Sen. Akaka (D-HI) sponsored a letter signed by 31 Senators to Chairman Byrd

- and Ranking Member Voinovich of the Senate Committee on Appropriations Subcommittee on Homeland Security requesting that EMPG funding be increased to \$530 million. Contacts from local emergency managers and their associations were vital to this effort.
- > For FY 2010, the President requested \$315 million for EMPG. The House included \$330 million and the Senate \$ 350 million. Conferees agreed on \$340 million. Chairman Price (D-NC) of the House of Representatives and Chairman Byrd (D-WV), Sen. Voinovich (R-OH), Sen. Roberts (R-KS) and Sen. Akaka (D-HI) led the effort to increase the funding. Sen. Roberts and Sen. Akaka sponsored a letter to the Appropriators signed by 37 Senators urging that EMPG be funded at \$487 million. Sen. Roberts sponsored the letter at the request of the Kansas **Emergency Management** Association during their Washington visit.
- > The FY 2009 Appropriations for the Department of Homeland Security / FEMA included \$315 million for EMPG - an increase of \$115 million more than the President requested, and \$15

- million more than the FY 2008 Appropriation.
- Emergency Management Institute. We also had success in obtaining additional Congressional appropriations, specific mention in the Appropriations reports and increased visibility for the Emergency Management Institute. The FY 2010 Appropriation included \$9 million, an increase of \$1.84 million over the President's request. The FY 2011 appropriation is still pending at the time of writing, but the Senate Appropriations Committee on Homeland Security included \$11 million, \$3.9 million more than the President's request. The FY 2009 Appropriation for FEMA included a specific mention of not less than \$7 million, an increase of \$1.253 million—the first increase in many years. IAEM continues to push for additional funding for updating classes and for development of an executive education program.
- Principal Federal Official. We have continued to oppose the appointment of a Principal Federal Official for a Stafford Act event. The FY 2010 DHS appropriations bill included a prohibition unless certain conditions were met. FY 2011 results not yet known.

- Supplemental Appropriations for the Disaster Relief Fund (DRF). We urged Congressional support for the \$5.1 billion Supplemental Appropriations for the DRF. Because of a shortage of funds, FEMA in February 2010 started allocating funds on an immediate needs basis and placed funding restrictions on repair, rebuilding and mitigation projects—holding back funding of approximately \$1.7 billion in projects. The Appropriations bill including the DRF funding was signed on July 29, 2010.
- Pre-disaster Mitigation. We have been engaged with efforts to reauthorize the program and remove the sunset provision. It has been necessary for the last few years to work to have the program extending one year at a time in the Appropriations bill.

- Stafford Act Amendments. We have been reviewing various Congressional amendments to the Stafford Disaster Relief Act.
- Full Implementation of the Post **Katrina Emergency Management** Reform Bill( PL 109-295). We continue to be a key voice in calling for PL 109-295 to be fully implemented as intended by Congress.
- Congressional Testimony and Meetings. We continued advocating our members' vital issues by providing testimony to Congressional committees and subcommittees. We continue to meet with key Congressional staffers to ensure that their members are aware of IAEM's positions. You can review our testimonies by referring to the table below. Details and copies of the

- We have had increased opportunities for substantive stakeholder involvement with FEMA and DHS and the White House. Some examples are as
  - Pam L'Heureux, CEM, IAEM-USA President; Eddie Hicks, CEM, IAEM-USA First Vice President; Randall Duncan, CEM, IAEM-USA Government Affairs Chair; Beth Armstrong, IAEM-USA Executive Director; and Martha Braddock, IAEM Policy Advisor, met with Richard Reed, Special Assistant to the President and Senior Director for Resilience Policy and other members of the White House National Security Staff to discuss the National Preparedness Policies under review on Mar. 9, 2010.
  - The committee worked to get the new administration to re-examine and look for a more apt implementation of both the Cost to Capability (C2C) initiative and the Integrated Planning System (IPS) as proposed in Fall 2008.
  - IAEM was asked to serve as one of 10 organizations comprising the Executive Committee for the DHS Quadrennial Homeland Security Review. On Nov. 19, 2010, Russell Decker, CEM, IAEM-USA Immediate Past President, and Nick Crossley, CEM, IAEM-USA Region 7 President, who was representing the National Association of Counties (NACo), were invited to meet with DHS Secretary Napolitano, key DHS leaders, and other representatives of the Executive Committee to review the preliminary findings and provide input.

- Representatives of IAEM and the National Emergency Management Association (NEMA) were invited to meet with FEMA headquarters grant officials in 2009 to review and suggest changes to the FEMA guidance for EMPG and EOC programs, and to meet with Elizabeth Harman, the Assistant Administrator of the Grants Directorate, in July 2010.
- IAEM-USA members were presented with a number of opportunities to comment on FEMA policies, particularly in the area of disaster assistance. These opportunities were facilitated by the committee.

#### Other IAEM-USA Government Affairs Committee activities included:

- Outreach to state association presidents and legislative chairs on key issues continues. Committee Chair Randy Duncan spoke at the Maine Association of Local Emergency Managers Conference. Policy Advisor Martha Braddock advised state association delegations on their Washington legislative visits and spoke at the conferences of the North Carolina and South Carolina emergency management associations. Key state association issues were discussed at the well attended IAEM-USA Annual Conference session for state association officials on Nov. 1, 2009.
- In Spring 2010, the IAEM-USA Government Affairs Committee, assisted ably by Jessica Jensen, Ph. D., Assistant Director of the Center for Disaster Studies and Emergency Management, faculty member at North Dakota State University, and committee member, distributed a survey to IAEM-USA members and state associations of emergency management on the use and value of EMPG funding. A second purpose of the study was to analyze the impact of the recent economic downturn on local emergency management programs. The committee reported the results of the survey in the IAEM Bulletin and on the IAEM website, and widely distributed a paper on Capitol Hill. The committee has used the survey findings to advocate on behalf of local emergency management programs in Congress.



IAEM-USA leadership met with key minority staff of the Senate Committee on Homeland Security and Government Affairs (HSGAC) to discuss Emergency Management Performance Grants, the Emergency Management Institute, disaster mitigation, and other issues of interest to local emergency managers and to Ranking Member Senator Susan Collins of Maine. This is the third year that the committee has conducted this survey, and it is anticipated that the survey will continue on an annual basis.

- We continue to work closely with our key partners, such as the National Association of Counties (NACo), the National Emergency Management Association (NEMA), the National Governor's Association (NGA), the National League of Cities (NLC), the National Conference of State Legislators (NCSL), and the Association of State Floodplain Managers (ASFPM). Randy Duncan discussed IAEM legislative priorities at the NEMA Legislative Committees meetings at NEMA's annual and winter conferences.
- Congressional and agency speakers are invited to the committee's midyear and annual conference committee meetings to address specific issues of special interest to our members and provide the opportunity for questionand-answer sessions. Our partners are invited to update us on their key legislative concerns.

- · IAEM-USA Children in Disasters Ad Hoc Committee Chair and IAEM-USA Region 1 President Bruce Lockwood, CEM, serves as an appointed Commissioner on the National Commission on Children and Disasters. Lockwood is Public Health Emergency Response Coordinator for the Bristol-Burlington Health District.
- "Children are 25% of our population. The Commission's 2010 report highlights the gaps that continue to exist in meeting the unique needs of children, as well as some of the initiatives currently underway to close these gaps," said Lockwood. "I encourage everyone to read the report and use it as a tool to incorporate children more fully into their emergency plans. Successful response and recovery will be reflective of our ability to meet the needs of the whole community, including our most vulnerable population-children."
- The commission's report cites persistent gaps in disaster preparedness for children since Hurricane Katrina five years ago. The report calls for the development of a national strategy for children in disasters to ensure that children are protected before, during and after an emergency. Among the findings of the report are seriously underfunded federal programs for school disaster preparedness, insufficient coordination among federal, state and local agencies responsible for children and lack of preparedness in the private health care system, including a finding that only six percent of hospital emergency rooms carry essential pediatric equipment. - numerous events at the Emergency Management Institute (EMI), Emmitsburg, Md., during the fiscal year on behalf of IAEM-USA, including: Master Trainer Focus Group, Executive Emergency Manager Focus Group, Training and Exercise Conference, Elected Officials Focus Group, and Core Competencies Focus Group.
- It is anticipated that a gap analysis will be conducted on what training and education curriculum currently exists within EMI and consortium for the development of a recommended list of existing courses for the various levels and to structure a work plan for the development of training to fill the identified gaps. Expectations should be high with regard to developed courses, provided EMI is able to obtain needed funding to move forward with course development and delivery.
- · IAEM-USA urges the appropriation of \$11.9 million for EMI; this is a \$2.9 million increase over FY 2010 appropriated, and \$4.9 million over the President's FY 2011 request. EMI provides vitally needed training to state, local and tribal emergency managers through on-campus and field-delivered classes, and through distance learning. This "crown jewel" of emergency management training suffered neglect over several years, which led to the degradation of training across the spectrum of its programs. The highest priority for FY 2011 continues to be the revision and upgrade of EMI's curriculum, which directly supports state, local and tribal emergency managers.
- IAEM-USA has called attention to the need for funding to address deferred maintenance and classroom technology needs in support of the entire USFA Campus. The "National **Emergency Training Center Facilities** Master Plan" requested by Congress has been completed. The plan indicates that \$21.2 million is needed to address current facility issues, and \$4 million is needed annually to address this ongoing need. IAEM-USA urges Congress to give careful consideration to maintaining and enhancing this vital facility.

- During the year, the IAEM-USA Special Needs Caucus members have very actively provided consensus edits, recommendations, comments and testimony on proposed legislation, drafted regulations and revised guidance. This has included, but not been limited to, public comment on HUD's adoption of the Architectural Barriers Act standards for housing, the Office of Disability Coordinator Act of 2009, expansion and formalization of new staff lines in FEMA for Regional Disability Coordinators, and a memo to Congress in reply to a Congressional hearing about special needs-inclusive emergency management practices.
- Members of the caucus have remained engaged as speakers and participants at numerous conferences, summits and gatherings addressing all-inclusive emergency management practices, the technology behind such practices, and the peer mentoring necessary to execute such practices in the field, thus contributing within our membership a multiplier effect.
- The caucus maintains and continues to add to its robust caucus Web page resources, articles, links and other materials on topics that are helpful to our peer IAEM members. We continue to select and invite to our conference call meetings and annual conference meeting persons who can present cutting edge issues on the topic for us to consider.
- Likewise, the caucus also tries to add value to the other IAEM caucus groups and has just undertaken an effort to revise earlier suggested CEM® exam questions on this topic for consideration. We also are preparing to draft study materials to better raise the level of awareness during the CEM® exam review process, hoping that the result will be better informed professionals ready to apply what they have learned to benefit all people they serve in practice.

 The IAEM-USA Special Needs Caucus released a statement codifying the IAEM-USA membership's commitment to support emergency management principles and practices without regard to ability or other circumstance and thereby applying our service to all people. This statement was released to coincide with the commemoration of the 20th Anniversary of the signing of the Americans with Disabilities Act in July 2010. Further, many individual members of the caucus participated across the country in celebration of this landmark civil right legislation. Caucus Chair Elizabeth Davis was present at the White House, as President Barack Obama and members of his administration, such as FEMA Administrator Craig Fugate, gathered to do the same.

#### **IAEM-USA Tribal Affairs Caucus**

- The IAEM-USA Tribal Affairs Caucus has been active this year in several areas and has seen some positive steps for the betterment of emergency management in Indian Country. The Emergency Management Institute has reached out to the committee, as they are working to re-vamp the tribal curriculum. Several committee members participated in the focus group that provided feedback to EMI on reorganizing three tribal courses and adding a fourth course that would be for tribal elected officials.
- At the IAEM-USA Mid-Year Meeting, Tribal Affairs Caucus Chair Charles Kmet met with Dr. Cortez Lawrence, EMI Superintendent, and Steve Golubic, FEMA Headquarters Tribal Liaison, to discuss the disparities in Indian Country and how EMI could help through its mission. One commitment from EMI was to increase funding for delivery of courses in Indian Country as well as provide support for a new initiative - development of tribal incident management teams.
- The IAEM-USA Tribal Affairs Caucus Chair was re-appointed to another

- three-year term on the FEMA National Advisory Council.
- The caucus continued to have strong interaction with the U.S. Government Affairs Committee by providing agenda briefings at the Mid-Year Meeting and Annual Conference as well as calls and other interaction throughout the year. This partnership between the two groups helps to ensure that correspondence that comes from DHS or FEMA is vetted through emergency management personnel in Indian Country.

#### **IAEM-USA Uniformed Services** Caucus

The mission of the IAEM-USA Uniformed Services Caucus is to foster mentorship and professional development among IAEM-USA Uniformed Services members; enhance communication and sharing of best practices between uniformed services emergency managers; provide advocacy to IAEM leadership on uniformed services emergency management issues; and increase interest, visibility and affiliation of IAEM-USA among the U.S. uniformed

The caucus facilitates the Uniformed Member and Civilian Emergency Manager of the Year awards, which recognize individuals serving in the Uniformed Services of the United States who have consistently demonstrated significant contributions to the field of emergency management while continuously self-developing as emergency managers.

#### **IAEM-USA Universities & Colleges Caucus**

 The IAEM-USA Universities & Colleges Caucus (UCC) held its 3rd Annual Workshop immediately preceding the IAEM Annual Conference. This year, the workshop was expanded to  $1 \frac{1}{2}$  days, and included presentations from active campus EM practitioners, other

- subject matter experts, and a variety of officials from the federal government. The more than 75 participants were provided with a forum to interact with each other, share information and practices, and learn from actual incidents and exercises on college and university campuses.
- Through the leadership of the UCC Region I representatives, and in partnership with the IAEM-USA President, the UCC forged a relationship with the FEMA Region I Federal Preparedness Coordinator, who advanced a concept within FEMA HQ to develop a Higher Education Center of Excellence within the region. A representative of the Federal Preparedness Coordinator presented at the 3rd Annual UCC Workshop.
- With the second wave of H1N1 Influenza hitting college and university campuses hard during the fall semester, the UCC introduced a Google-based map detailing the on-campus suspected and confirmed cases, mitigation strategies, and other information in near-real-time. The U.S. Department of Education Office of Safe and Drug-Free Schools (ED-OSDFS) used the map and information to keep updated on the national situation; ED-OSDFS also engaged the UCC to conduct a brief survey on H1N1 Influenza vaccinations. The Centers for Disease Control and Prevention (CDC) used the UCC, the map and the UCC listserv to help conduct a research study on H1N1 Influenza on college and university campuses.
- With the assistance of the IAEM-USA Policy Advisor and the support of the IAEM-USA Government Affairs Committee, leaders of the UCC met with Congressional staff members to provide briefings on the role of EM on college and university campuses. In addition, UCC leaders met with officials from the U.S. Department of Education and FEMA to discuss a variety of topics, including accreditation, training and EM practitioner needs in the campus environment.
- In October, the final regulations implementing the Higher Education Opportunity Act (HEOA) and its

campus safety provisions were published; the UCC had representation on the negotiated rulemaking committee; the UCC also assisted the U.S. Department of Education on developing a revised campus safety regulations compliance handbook; publication of this handbook is scheduled for early Fall 2010.

- The UCC initiated a series of webinars, starting with a joint project with the Campus Safety, Health and Environmental Management Association (CSHEMA) on the campus safety provisions of the Higher Education Opportunity Act; approximately 90 institutions participated in this event. The second in the series was a webinar on successful grant application writing, given in advance of the U.S. Department of Education Emergency Management in Higher Education (EMHE) grant program deadline; more than 70 institutions participated in this hourlong Web-based seminar. Additional webinars are being planned on a variety of topics.
- Six members of the UCC were chosen to provide representation and subject matter expertise to a newly-formed working group of the Emergency Management Accreditation Program (EMAP). The working group is charged with developing a pilot program using the EMAP Standard to assess higher education institutions. It is anticipated that four institutions will be chosen to take part in the pilot, tentatively slated for 2011. A cooperative agreement between FEMA and EMAP is funding this pilot project.

# **National Conference on Community Preparedness:** The Power of Citizen Corps

On Aug. 10-12, 2009, the National Conference on Community Preparedness: "The Power of Citizen Corps," co-hosted by FEMA's Preparedness Division/Citizen Corps and IAEM in collaboration with NEMA, under a Cooperative Agreement with the Department of Homeland Security, brought together 836 participants. It was the second national conference on community preparedness and was highly successful. The conference addressed a comprehensive scope of issues related to preparing America's communities for all types of emergencies and increasing resilience through collaborative planning, citizen training and multi-sector participation. FEMA Administrator Craig Fugate used the platform of the conference to confirm national leadership support for collaborative grassroots community preparedness.

Other speakers included Russ Decker, David Maxwell, Richard Hatchett, and Bruce Lockwood from IAEM-USA, NEMA, the White House and the private sector. The conference brought together representatives from Citizen Corps Councils at the national, regional, state and community levels. The program was established and approved by FEMA's Community Preparedness Division/Citizen Corps with input from IAEM-USA. The program provided a retrospective of the past, highlighted new directions in community preparedness initiatives, funding and collaboraManagement System and the National Response Framework. A unique feature of the conference was the first-ever presentation of the National Citizen Corps Achievement Awards, "Celebrating Resilient Communities for 2009." These awards recognized innovative practices and achievements of Citizen Corps Councils across the nation that continue to make our communities safer, stronger and better prepared to manage any emergency situation. It was noted that the finalists exemplified excellence in community emergency planning, fostering successful public-private partnerships, prioritizing collaboration, demonstrating creative and innovative local problem solving, and implementing sound programs that can be modeled for use by other communities.

Recognizing that a special partnership exists with state and local emergency managers, especially with our increasingly more active advisory role in defining national FEMA policies, an invitation-only Emergency Managers Roundtable was held in conjunction with and immediately following the National Conference on Community Preparedness. The exhibit area which was organized and managed by IAEM staff, although separated from the conference, was a highly popular and well-attended event.

At the IAEM 2009 Annual Conference, the IAEM-USA Board took a unanimous position to support a continuation of a Cooperative Agreement with Citizen Corps to manage/support the National Community Preparedness Conference and supported a recommendation for funding for annual conferences.
