The mission of IAEM is to serve its members by providing information, networking and professional development opportunities, and to advance the emergency management profession.

CEM® and AEM Programs www.iaem.com/CEM

Since the Certified Emergency Manager® Program was introduced in 1993, 4,638 have enrolled to pursue the CEM® designation. (Last year at this time, there were 3,300). Of these, by May 31, 2008, 1,207 had been awarded the Certified Emergency Manager® (CEM®) credential and 10 had

been awarded the Associate Emergency Manager (AEM) credential.

About 117 candidates await review or are in the application process (candidates have made a submission, and staff or commissioners have requested additional information). Only 32 of those pursuing the credential are IAEM members — IAEM membership is not required to participate in the CEM® program. IAEM members realize a fee discount, since the general fund subsidizes in part the program operations. The CEM® Preparatory Course and CEM® Exam were offered in five locations, including:

- June 13, 2007, IAEM Mid-Year Meeting, Alexandria, VA, USA.
- July 7, 2007, WCDM, Toronto, ON, Canada.
- Nov. 11, 2007, IAEM Annual Conference & EMEX, Reno, NV, USA.
- Feb. 3, 2008, National Emergency Management Summit, Washington, DC, USA.
- Mar. 31, 2008, Partners in Emergency Preparedness Conference, Tacoma, WA, USA.

IAEM recognized the commitment of FEMA leaders to support the involvement of their Federal Coordinating Officers as IAEM members, including their enrollment in the CEM® Program. FEMA enrolled all 34 FCOs as members and CEM® program applicants.

On Aug. 30, 2007, current and future IAEM members in five countries learned how to earn the CEM®. Twenty people came to a dinner meeting in Singapore, and members in India, Hong Kong, Indonesia and the Philippines watched and heard the presentation online. In his audio and Web presentation, CEM® Commission Vice Chairman Nick Crossley, CEM, provided an explanation of CEM® requirements.

CEM® Program Changes

- The IAEM Board approved a change to the CEM® Program that repositions the Associate Emergency Manager (AEM) credential as an "entry-level" certification, allowing beginning professionals to engage in the certification process and begin establishing a benchmark of their professional activity.
- The CEM® Application Packet is now available for download at no charge from www.iaem.com/CEM. Online registration with provision of contact information is required, but application fees are not incurred until the application packet is submitted. This change in procedures allows CEM*/AEM candidates to use the actual application to self-assess and determine their qualifications, while streamlining the administrative process. By requiring registration, IAEM still

collects contact information for those interested in the certification program. IAEM uses the contact information to let candidates know about membership and conference opportunities, while periodically encouraging them to follow through with their CEM® application.

- The CEM*/AEM Study Guide was updated effective Apr. 8, 2008, and is posted for download on the IAEM Web site.
- The requirements for Lifetime CEM* eligibility were updated effective Apr. 9, 2008, to mandate that a candidate must be a current Certified Emergency Manager® at the time of their application for Lifetime CEM® status. Lifetime CEM® status is an honor bestowed by the CEM® Commission.
- The CEM* bank of test questions for the exam was updated this year to allow specialized versions of the test depending on location of applicants.

IAEM-Global

The internationalization of IAEM began in 2002 with the creation of the International Development Council, which created the road map to accomplish this goal. The first steps involved the active recruitment of members outside the United States and the establishment of new membership "regions" within the current IAEM structure. The process continued through membership approval of bylaws amendments in November 2007, which established independent councils under the IAEM-Global banner. Each council has its own bylaws and administrative policies and procedures, and oversees its own officer elections.

The International Association of Emergency Managers is governed by an international Board of Directors that includes representatives from each of the seven (7) IAEM Councils, plus one (1) additional Council representative per 500 members up to four (4) representatives. IAEM Councils include: IAEM-Asia, IAEM-Canada, IAEM-Europa, IAEM-International, IAEM-Oceania, IAEM-Students and IAEM-USA.

IAEM-GLOBAL COMMITTEE REPORTS

These committee activities are focused on the international activities, governance and representation of IAEM. ship approved the bylaws change in an association-wide election as of November 2007. The committee continues to review bylaws on a regular basis.

Awards & Recognition Committee

- The Awards & Recognition Committee, under the leadership of Committee Chair Phyllis Mann, updated and streamlined the IAEM Awards guidelines and competition process for 2007, with further refinements in 2008. Award entries are now electronic and judging takes place remotely, allowing IAEM to tap into the expertise of a wider variety of judges. New award categories included the Career Excellence Award and the Academic Recognition Award.
- This year, the committee was pleased to receive a record 100 award entries.
 Award winners are recognized at the IAEM-USA Annual Conference.

Bylaws & Resolutions Committee

• The Bylaws & Resolutions Committee, under the leadership of Committee Chair Dan Maher, CEM, reviews IAEM Bylaws and makes recommendations for revisions. In June 2007, the IAEM Board drafted a revision to the bylaws that would allow an international structure to become a reality. The IAEM member-

its 25th year of publication. Editorial Committee members assist *IAEM*Bulletin Editor Karen Thompson in the selection of special focus topics, recruit subject matter experts to author articles, and function as liaisons to the IAEM Board on communications issues.

- Special focus topics for 2009 will include EM communications, research to practice, and faith-based organizations in response and recovery.
- The committee established and maintains the EM Practitioner Articles searchable online collection of articles, posted in Members Only at www.iaem.com to collect and preserve information of value

- to IAEM members. Dean Larson, Ph.D., CEM, IAEM Editorial Committee Vice Chair, oversees the review process, and articles that contribute to the advancement of knowledge and improvement in the practice of emergency management are welcome. Announced in October 2007, the collection now hosts 25 papers and reports, with new additions every month. IAEM thanks members of the American Society of Professional Planners (1994-2004), as this searchable compendium of articles was established in part through a bequest from ASPEP.
- The committee's proposal to provide university libraries with complimentary subscriptions to the *IAEM Bulletin* was approved by the IAEM Board. The *Bulletin* is available to university and college libraries at those schools that offer EM-related programs. University librarians may request subscriptions at info@iaem.com, providing their full mailing address, a short description of their institution's EM-related program, and a link to their institution's Web page with more program information.

Marketing & Membership Committee

- The Membership and Marketing Committee managed the production of two IAEM promotional videos. Thom 2 Productions, at the direction of the working group, filmed personal interviews from IAEM members and supporters during the 2007 IAEM Annual Conference. The committee had oversight of the script and final product. Two videos were produced: a promotional video and a testimonial video. Both videos are available on the IAEM Web site. Members may request from headquarters a DVD for use during formal presentations.
- The committee identified target audiences and venues and encouraged formal IAEM participation at allied events and exhibitions.

Web Site Committee

 The Web Site Committee oversaw the original development of voting procedures and voting informational areas to accompany the first IAEM online elections, and that effort has continued with elections held during this fiscal year

- on the global, council and U.S. regional levels. Web site navigation was updated to reflect the new IAEM global organizational structure.
- An IAEM Outreach section was added to the Web site at www.iaem.com/Outreach, providing a complete list of IAEM members who are serving the association as liaison representatives with allied organizations and work groups.
- The committee has continued to work toward providing the latest news of interest to IAEM members. Committee Chair Nick Crossley, CEM, engaged in active networking throughout the year to solicit member opinions and discuss ways in which IAEM can boost the value of Web site content.

IAEM-Asia was formed in June 2008, covering 30 countries and territories between the Oceania and Europa councils. Although the formation occurred after the fiscal year ended, plans were well underway during the fiscal year covered by this report.

 Members elected council officers from China, Malaysia, Philippines and Singapore, and IAEM-Asia membership doubled to more than 80 in 2008. The council held two general membership meetings in Singapore, both accessible to all council members by conference call.

- The IAEM-Asia web site at www.iaem. com.sg was redesigned to offer more information to members and to attract new members.
- IAEM-Asia focused on offering training in Asia to help members achieve CEM* certification. Toward that goal, IAEM-Asia partnered in 2008 with the premier EM training providers in Asia: the Singapore Civil Defence Academy (SCDA) and the Asian Disaster Preparedness Centre (ADPC) in Thailand. IAEM reviews and approves partners' courses for CEM* training credit; the partners promote IAEM membership to course participants.
- India National Representative Kailash Gupta delivered a presentation about IAEM at a plenary session on enhancing public-private partnerships in risk reduction, part of the 2nd Asian Ministerial

- Conference on Disaster Risk Reduction, Nov. 7-8, 2007, New Delhi.
- IAEM-Asia partnered with Cisco Systems to use its TelePresence videoconference technology to arrange a July 2008 IAEMsponsored meeting between Australian and Singapore banking contingency planners.
- IAEM-Asia partnered with Alphabet
 Media to endorse a disaster management, response and recovery conference
 for Asia in October 2008. IAEM officers
 will speak at the conference, and IAEM
 and Cisco Systems are co-sponsoring a
 videoconference.

- IAEM-Canada established five committees and is in the process of incorporating IAEM-Canada as a not-for-profit organization in Canada.
- IAEM-Canada members engaged in reviewing the Canadian Standards Association's Z1600 Standard for Emergency Management and Business Continuity.

- IAEM-Europa held its inaugural Annual General Meeting in association with IDER 2007 in London, where IAEM President (2006-2007) Michael Selves, CEM, was the keynote speaker on the UN Day of Disaster Reduction.
- IAEM-Europa President Arthur Rabjohn, CEM, presented IAEM awards to Herve Martin and Fabio Pirotta during the IAEM-Europa supported 2nd Civil Protection Forum, Nov. 22-23, Brussels.
- Rabjohn compiled IAEM-Europa member comments on the Pitt Review of the 2007 UK floods.
- Michael J. Fagel, Ph.D., CEM, delivered a presentation on U.S. pandemic planning guidelines, as well as a briefing on the CEM* program and activities of the IAEM-Europa Council, to an EM delegation from Prague, Czech Republic, hosted by the City of Chicago's Sister Cities Program in February 2008.
- IAEM-Europa members supported the future of emergency management by making a significant contribution to the IAEM Scholarship Fund.

- IAEM-Europa has formed a number of partnerships that will raise its profile among the European civil protection and contingencies sectors, including partnerships with the Crisis Response Journal, Emergency Planning College, European Emergency Number Association, EU's Emergency Response to Coastal Oil, Chemical and Inert Pollution from Shipping Project, Journal of Business Continuity and Emergency Planning, Seguranca em Proteccao Civil, and Wessex Institute of Technology.
- Upcoming conferences supported by IAEM-Europa include the Emergency Services Show 2008 in Stoneleigh Park, Coventry, England; IDER 2008; the ERES 2009 7th International Conference on Earthquake Resistant Engineering Structures in Cyprus; the SAFE 2009 3rd International Conference on Safety & Security Engineering in Rome; and the 1st International Conference on Disaster Management and Human Health in New Forest, England.
- IAEM Europa is now well-positioned to expand its membership activity and representation as new members join.

- IAEM-Europa has completed its second year as an IAEM council, and while member growth hasn't been as fast as hoped for, there have been a number of significant successes. Membership has grown to include 28 countries.
- Instituto Politechnico de Castelo Branco (IPCB) in Portugal formed the first IAEM Student Chapter outside of North America.
- IAEM-Europa is pleased to be the first IAEM Council outside of North America to be offering IAEM members and other emergency management practitioners the chance to sit for the CEM* Exam. An introduction presentation and the exam will take place during an IAEM-focused afternoon on Oct. 13, 2008, at the IDER 2008 (International Disaster and Emergency Resilience) Conference in London, an event which IAEM-Europa is supporting for a second year.

IAEM-International

- The IAEM International Council includes all IAEM members who reside outside the other Council areas and currently represents members in 17 countries.
- During the fiscal year, IAEM-International collaborated with IAEM Headquarters to facilitate the creation of IAEM-Asia. First efforts toward development of IAEM-Asia began in 2004. IAEM-Asia's first council president, Nathaniel Forbes, was originally the IAEM-International Council's national representative for Singapore.
- IAEM-International is now focusing on creating a new council in either Africa or the Middle East before the end of the 2008-2009 fiscal year. In order to accomplish this goal, the council is intensifying efforts at enhancing collaboration between countries within a geographic region. To enhance coordination of local activities, country representatives are now encouraging the formation of online Yahoo Groups as a cost-effective tool for creating cohesion with members and potential members. The pioneer online group is active in the Middle East, and chances of forming an IAEM Council in the Middle East have significantly improved of late.
- Due to difficulties with online membership payments, African representatives and IAEM-International are exploring new alternatives for membership payment in countries where credit cards are not in common use.
- Efforts are underway by IAEM-International to participate in local conferences in Brazil, East Africa and South Africa. Recently, IAEM-International Vice President R. Martín Closa represented IAEM at a conference in Argentina. The council has identified potential representatives and promoters in the South American countries of Brazil and Argentina.
- Currently there are a number of challenges facing the IAEM-International
 Council. These include linguistic barriers, the slow adoption of emergency management as a profession, and the lack of significant local benefits

for council members. The council effort to increase local coordination is aimed at reducing these barriers to growth. Despite these challenges, IAEM-International leaders are working to create new regions through which IAEM membership benefits will reach all members within IAEM-International, which is the most diverse IAEM council, being extremely fragmented by geography, diversity and culture.

IAEM-Oceania

- Created in March 2007, IAEM-Oceania has attained not-for-profit charitable institution status in Australia and is working toward the same in New Zealand.
- In April 2008, an IAEM student chapter was created at the University of Canterbury in Christchurch, New Zealand. There is a strong focus on building student membership within IAEM-Oceania, and a second student chapter is on the way.
- IAEM-Oceania has consolidated and refined its web site at www.oceania-iaem.

- com, which is the council's main vehicle for the facilitation of information sharing, networking and supporting local events.
- IAEM-Oceania is increasing knowledge and acceptance of the CEM® as a highly relevant credential. IAEM-Oceania members have achieved their first two CEMS®, including IAEM-Oceania Vice President Kristin Hoskin, CEM, and Steve Glassey, CEM. Members have representation on the CEM® Commission, and are well on the way to establishment of the Oceania CEM®. The Australian and New Zealand national representatives have taken the council membership to almost 200.

IAEM-Students

• The IAEM Student Council has worked with the IAEM Board to define the unique role and organizational structure for IAEM student members. This agreement allows the IAEM Student Council to focus on new bylaws, as well as student region chapter development, in the coming fiscal year. The council grew to 23 student chapters during the fiscal year.

- The Responder, the first IAEM Student Council newsletter, includes chapter reports, IAEM committee information and member articles. New communication forums, including groups on both Facebook and MySpace, were instituted. The chapters at American Public University System, Metropolitan College of New York, and North Dakota State University publish student chapter newsletters, and several chapters have their own Web sites.
- In May 2008, the council announced a call for entries for its expanded Second Annual IAEM Student Poster Competition, giving student members the opportunity to identify and analyze an issue, research it, and articulate conclusions and proposed solutions.
- The council continued the tradition of a yearly survey of students of emergency management. Council President Brian Silva presented survey findings at the FEMA Higher Education Conference.

- Council members reformed the process for creating new student chapters with standardized paperwork, a mentor to help students through the process, and additional resources to make the process easier and more successful for applicants.
- The council also developed a "student track" for the IAEM 2008 Annual Conference that will include student social, networking, academic and professional development events.

The NAC advises the FEMA Administrator on all aspects of preparedness and emergency management in an effort to ensure close coordination with its partners across the country.

IAEM-USA Standing Committee Accomplishments

CONFERENCE COMMITTEE

- With the goal of moving the annual conference experience into a new league, Conference Committee Chair Carolyn Harshman and Co-Chair Dan Robeson, CEM, led efforts to produce the IAEM 2007 Annual Conference a great success with a significant increase in attendees and EMEX exhibitors. They were assisted by Mike Martinet, CEM, in identifying plenary speakers.
- Advancing the planning process to begin building interest among speakers and vendors, the committee announced an early selection of the IAEM 2008 Annual Conference theme, "Putting a New Spin on Emergency Management." The first action of the committee was to review the 2007 evaluations. Another early action was a request for an increase in its annual budget by the Board of Directors. The increase allowed for a greater number and compensation range for professional plenary speakers, as well as funds to support an additional track of breakout speakers.
- The committee continued to be responsible for the Volunteer Cadre. Thanks to
 the continuing effort of Co-Chair Dan
 Robeson, CEM, processes were refined
 for establishing standards for volunteer
 service.
- Due to the success of the 2007 conference, the committee received 380 breakout speaker submissions for the 2008 conference sessions. The committee worked to develop an academic, contemporary and historical list of books to be offered at the 2008 conference. EMEX 2008 will include a bookstore as well as a stage for featured authors to address the audience and conduct book signings.
- The committee dedicated many hours to working with IAEM professional staff to improve on the overall conference experience, including adequate time between breakout sessions, increase in student networking opportunities, more computer kiosks, research into Wi-Fi opportunities, and better access for participants with special needs.

 The 2007 conference was home to the first "EMI@IAEM" opportunity, and the committee is excited about the strong bond now established between the two organizations. In 2008, FEMA's Emergency Management Institute increased its commitment to provide more pre-conference courses at the IAEM annual conference.

GOVERNMENT AFFAIRS COMMITTEE

 The U.S. Government Affairs Committee greatly accelerated the pace of its activities, interacting with Congress and senior FEMA leadership and being consulted on a wide variety of policy initiatives. The committee, led by Robert C. Bohlmann, CEM, and Vice Chairs Matt McCracken and Randall C. Duncan, MPA, CEM, was supported by IAEM Policy Advisor Martha Braddock. The voice of U.S. emergency management was heard clearly in the halls of Congress and the headquarters of FEMA, with the constant support of the IAEM-USA Board of Directors and IAEM-USA membership. See Figure 1 on Page 10 for hearing details. Copies of testimony and other key documents are

- The result of the increased pace of activity is apparent. More IAEM-USA members and members of state associations have engaged their Congressional representatives. That effort has been critical to the impact of the committee. Since Members of Congress have many requests for funding and legislative changes, it is vital that they understand what they are getting for the money or the effect of a legislative change and why it matters to the local emergency manager back home. Our unified effort continues to support decisions that ensure adequate EM resources and operations.
- The committee had extensive input into the Post Katrina Emergency Management Reform Bill, PL 109-295, and most of the IAEM "Principles for Strengthening FEMA" were included. This year IAEM-USA continued to be a key voice in calling for the law to be implemented as intended by Congress within FEMA, in our review of policies, and with Congress.

- The committee has continued to resolutely emphasize the importance of the
 Emergency Management Performance
 Grant (EMPG) program to local and state
 emergency management programs
 by explaining why funding increases
 remain a high priority. We have achieved
 successes in the following areas:
- Increasing EMPG funding and retaining it as a separate account.
- Maintaining the all-hazards nature of EMPG funding, despite some program guidance that initially may have indicated otherwise.
- Getting FEMA to issue a clarification to EMPG guidance indicating that the traditional uses of EMPG funding were still allowed, including the use of funding for personnel.
- The FY 2008 Appropriations for the U.S. Dept. of Homeland Security/FEMA included \$300 million for EMPG — an increase of \$100 million more than the President requested. For Fiscal Year 2009, the President requested \$200 million; as of publication of this report, the House Appropriations Committee markup included \$315 million and S. 3181, the Senate Appropriations bill for DHS, included \$300 million. For both years, Chairman Price (D-NC) of the House of Representatives and Chairman Byrd (D-WV), Sen. Voinovich (R-OH) and Sen. Akaka (D-HI) have led the effort to increase funding. In April 2008, a letter signed by 50 Senators urged that EMPG be increased to \$487 million.
- IAEM-USA was a key partner in protecting the interests of emergency

- managers in EMPG and Emergency Operations Centers in HR 1, the Bill to Implement the Recommendations of the 9/11 Commission report.
- In addition, the committee has been actively engaged with Congress to promote the mission and importance of the Emergency Management Institute, to reauthorize the Pre-Disaster Mitigation Program, to support the National Weather Service, to abolish the role of the Principal Federal Official, and to review amendments to the Stafford Disaster Relief Act.
- The committee made a concerted effort to work closely with other IAEM committees on legislative and government affairs issues, appreciating their expertise and input. The committee has worked closely with IAEM-USA partners, such as the National Association of Counties, the National Emergency Management Association, the National Governor's Association, the National League of Cities, the National Conference of State Legislators, and the Association of State Floodplain Managers.

NOMINATIONS & CREDENTIALS COMMITTEE

 Led by Committee Chair Eddie Hicks, CEM, the Nominations & Credentials Committee collected letters of candidacy for national office, vetted candidates' eligibility, presented a slate of candidates to the membership prior to the IAEM Annual Conference, and validated voting member credentials and election results.

PUBLIC-PRIVATE PARTNERSHIPS COMMITTEE

The Public-Private Partnership
 Committee, under the leadership of
 Co-Chairman Shane Stovall, CEM, began
 review and renewal of the committee's
 mission, vision and objectives. The
 goal is to revitalize and refocus the
 committee, and develop a direction for
 future committee programs and projects.

STRATEGIC PLANNING COMMITTEE

 Committee Chair C.J. Howard and Vice-Chair Mike Mumaw are drafting the IAEM-USA Strategic Plan and preparing for discussion at the IAEM-USA 2008 Annual Conference.

TRAINING & EDUCATION COMMITTEE

- Under the leadership of Kay Goss, CEM, Training & Education Committee membership tripled and the committee met three times during the fiscal year.
- Highlights of the committee's work included: support for increased appropriations for the FEMA Emergency Management Institute; support for and attendance at the FEMA Higher Education Conference, the largest so far with representatives from nine countries more than 150 degree programs; and discussion with the FEMA EMI Superintendent about creating an annual recognition of the outstanding trainer and outstanding educator of the year.

TRIBAL AFFAIRS COMMITTEE

- Tribal Affairs Committee Chair Charles Kmet, Robert Nelson and Tim Sanders participated in conference calls with senior leadership of the FEMA Grants Preparedness Directorate, the Government Affairs Committee Chair, and others to discuss DHS grant allocations and suggest future improvements.
- Kmet is a member of the National Advisory Council (NAC), which has submitted a report to FEMA Administrator Dave Paulison on regulatory changes needed for the Stafford Act. Tribal issues are so in-depth that a beginning statement as it relates to tribal issues within CFR 44 Emergency Management & Assistance should be included. At the May 2008 NAC meeting, Kmet's presentation on tribal affairs and issues was well-received, as many NAC members do not have much interaction with tribes in their home communities. That discussion is leading toward possible formation of a working group that could put together a position paper on tribal issues and emergency management.
- The committee has encouraged members to become engaged with their FEMA Regional Advisory Councils, as each of them are supposed to have a tribal representative.

UNIFORMED SERVICES COMMITTEE

 The Uniformed Services Committee, under the leadership of COL Bob Ditch, CEM, continued to enhance communication and foster mentorship to new IAEM Uniform Services members and to increase interest and visibility of IAEM among the military services, USCG, PHS, NOAA, and National Guard components.

IAEM-USA Special Interest Committees

EMERGENCY SERVICES COMMITTEE

- The Emergency Services Committee, led by Chair Pat Fugate, provides representation from functional areas that are not considered "emergency management." First steps have involved defining the disciplines that are represented within IAEM membership and devising a method of communication to appropriate individuals when requests for input are made.
- Committee activities have included: completion of an organizational chart

- to define disciplines and assign lines of communication; assignment of members to each of the functional areas on the organizational chart; and development of a member survey to better define who was available and what capabilities were available.
- A mission statement has been drafted, but not finalized. A number of requests for input, representation and provision of expertise have been made this year.
- Committee members John Walsh and Erik Gaull represented IAEM for the Office of Infrastructure Protection of the Department of Homeland Security's proposal for a collaborative approach to develop and validate a sector-specific Pandemic Influenza Planning Guideline.
- Committee members submitted several best practice examples for the DHS Best Practices Initiative.
- Pam L'Heureux and Erik S. Gaull, CEM, provided representation for the Office of Emergency Communications (OEC) National Emergency Communications Plan (NECP).

 Committee members provided comments for the DHS Emergency Services Sector — Sector Specific Plan revisions for 2008.

SPECIAL NEEDS COMMITTEE

- At the request of Daniel Gade, Associate Director for Domestic Policy at the White House, the Special Needs Committee provided a briefing, available at www. iaem.com/committees/specialneeds.
- Led by Committee Chair Elizabeth Davis, the Special Needs Committee continued to monitor and share via the discussion list any breaking news affecting special needs populations, including items for consideration by members in local plan development. One public comment opportunity shared by the committee was the draft version of At-Risk Populations and Pandemic Influenza: Planning Guidance for State, Territorial, Tribal and Local Health Departments, released by the Association of State and Territorial Health Officials.
- The committee conducted an informal survey of peers via the IAEM discussion list to ascertain industry familiarity with the U.S. Dept. of Justice (DOJ) guidance issued in July 2007 touching on issues such as special needs sheltering. The survey results are being discussed by the DOJ disability rights unit and have helped to inform the national conversation.
- Committee members continue to be sought as subject matter experts in the field, as evidenced by the number who teach special needs training at EMI, publish in scholarly journals on the subject, sit on national boards such as the NAC, and appear at conferences.
- The committee compiled IAEM member comments on the 2007 Sheltering Guidelines and presented them to the National Disability Coordinator, who often calls on the committee for advice.
- The committee solicited submissions to the research project for the National Council on Disability under H.R. 5441.
- The committee continues to use the committee meeting time during the annual conference to select one topic of focus and provide a teaching session that is open to all IAEM members.

UNIVERSITIES & COLLEGES COMMITTEE

- The official UCC listserv, hosted by the University of Oregon, is dedicated solely to the practice of emergency management on college and university campuses; the list is a mechanism for campus EM practitioners to collaborate, share information, and provide news about higher education and emergency management. All e-mails generated on the list are archived and searchable. At the end of the fiscal year, the list had 370 members from the United States and Canada.
- The first workshop for college and university EM practitioners was held during the IAEM 2007 Annual Conference. With an invited attendance of 59, topics ranged from building relations with the community to incorporating students into EM programs. Another workshop is being planned for the 2008 conference.
- The UCC has been working with EMAP (Emergency Management Accreditation Program) to develop a pilot project that will accredit higher education institutions; the formal announcement is expected in 2009. In anticipation of the announcement, EMAP will be holding two assessor training programs in Fall 2008, at Florida State University and the University of California, Davis.
- A repository for information was developed for the UCC at the University of California, Davis. The repository holds documents such as sample plans, position descriptions, exercise templates, training programs and other related items. The site, created to encourage information and document sharing among campus EM practitioners, was launched in May 2008.
- Throughout the year, members of the UCC tracked proposed amendments to the Higher Education Act of 1965; the bills, from both the House of Representatives and the Senate, seek to

require colleges and universities to have emergency communications systems in place to notify the campus community; the bills have other provisions that have implications for emergency management as well. The UCC is working with the IAEM U.S. Government Affairs Committee to design a position paper on the proposed legislation. The position paper was submitted, approved and posted at www.iaem.com/Committees/College/.

• The UCC, through the Disaster Resistant University listserv and other means, was instrumental in providing information to U.S. colleges and universities about the Department of Education Emergency Management in Higher Education (EMHE) grant program, funded for the first time in 2008. Partly as a result of this outreach by and promotion of campus-based emergency management through the UCC, over twice as many higher education institutions applied for this grant program as was expected by the U.S. Dept. of Education.

IAEM-USA Activities with Allied Organizations and Partnerships

IAEM-USA and its members were frequently asked by the U.S. Dept. of Homeland Security (DHS) and other agencies to provide feedback on policy changes or submit testimony on important issues of the day, including:

- IAEM was among stakeholders who met with FEMA leaders on Oct. 25, 2007, as part of a series of continuing discussions on opportunities to improve the National Response Framework (NRF). IAEM was represented by IAEM First Vice President Russell Decker, CEM, and IAEM Executive Director Elizabeth B. Armstrong, MAM, CAE. Further IAEM comments on the NRF were submitted to DHS on Nov. 13, 2007.
- USGA Committee Chair Bob Bohlmann, CEM, compiled member comments on FEMA draft policies in regard to seismic

- safety and new construction, construction codes and standards, the disaster recovery purchasing program, the FEMA drought plan, rehabilitation assistance for levees and other flood control works, replacement of animals associated with eligible facilities, repair vs. replacement of a facility, private nonprofit museum eligibility, damage to applicant-owned equipment, and guidance for allowing non-governmental entities to offer disaster assistance services in a disaster recovery center.
- Steve Detwiler, facilitator of the IAEM NRP/NIMS Working Group, compiled member comments on various draft documents dealing with the National Incident Management System (NIMS).
 IAEM comments on FEMA documents pertaining to search-and-rescue resources and the FEMA/NIMS resource



Financial Performance

The IAEM total fund balance as of May 31, 2008, was \$753,020, up \$142,617 from the cash balance at the beginning of the fiscal year. This included \$51,929 in cash (BB&T checking account), and \$701,091 in treasury bills, mutual funds, and other conservative investment vehicles. With average monthly expenses of \$109,778, the current reserve could sustain the organization for approximately six-and-a-half months. Operating receipts for 2007-08 were \$1,439,682 and expenses were \$1,317,345 (excluding CEM* and scholar-ship operations).

Membership Growth

Highlights:

- A new IAEM Council was created during the fiscal year: IAEM-Asia (80 members).
- The largest Council is the IAEM-USA Council, with 2,631 Individual Members (60%). The second largest Council is the Student Council with 1,042 Student Members (25%).
- In the IAEM-USA Council, Region 3 is the largest region (521 members), followed closely by Region 4 (514 members).
 Region 9 is the third largest region (355 members).
- The IAEM membership includes Individual Members (73%), Affiliate Members (2%), and Student Members (25%).
- Instituto Politechnico de Castelo Branco (IPCB), Portugal, became IAEM's first student chapter outside of North America.

IAEM's final roster for 2007-08 included:

 4,199 paying members, an increase of 1,050 members over 2006-07 (33 % membership growth) as of May 31, 2008.
