Tom briefing the program.

何飞友介绍了该方案的简况。

Mr. Xia was explained the form of the alliance and operation, he stated that the alliance is required a registration by government based on the alliance operation guidelines and membership management to avoid conflicts of members' benefits.

Mr. TJ Gu expressed that the alliance could be a platform for members to promote their products and services in China.

It is suggested to remain the role of the center should set apart of the industry alliance. However, it is considerable to join ours into other industrial alliance to operate.
