IAEM Mission

Caucus Defined:

<u>IAEM Bylaws, Article VII – Section 3, p. 5</u> - "Caucuses are groups with a special focus or function within the practice of emergency management."

Guidance:

<u>IAEM – APPs, III. Committees, A. General - p. 29</u> - "Caucuses are groups with a special focus or function within the practice of emergency management. They meet occasionally and provide advice to the organization. These groups of individuals could provide IAEM with program and product advice from the unique perspective of a particular industry or topic"

<u>IAEM – APPs, III. Committees, A. General - p. 31</u> - "Caucuses must have at least 20 participants in order to be recognized as a caucus"

Members must commit to participate in the quarterly meetings and be engaged in the Caucus on a regular basis. To join, an individual must be a member of IAEM in good standing.

Caucus Roles and Responsibilities

Special Focus or Function (per Bylaws/APPs): Faith-Based Organizations

Purpose Statement:

The purpose of the IAEM-USA Faith-Based Organizations Caucus is to advocate for the increased recognition and engagement of faith-based organizations in IAEM-USA and the emergency management community toward building stronger and more resilient communities.

GOALS/OBJECTIVES:

- 1. Determine/confirm current roster of IAEM members who identify with a faith-based organization. **NOTE:** As of June 7, 2017, of 3,211 members listed in the online database, 26 individuals self-identified as having an affiliation with a faith-based organization (3 members with Christian colleges, 1 member with Crossroads Church, and 22 members with The Salvation Army). Based on this information, 8 percent of the IAEM membership is affiliated with a Faith-Based Organization.
- 2. Once identified, notify current IAEM faith-based members of the Caucus and invite them to join. Also, reach out to other members of IAEM who may be interested in participating in the Caucus.
- 3. Devise, develop and implement a plan for outreach in coordination with Membership and Marketing to build IAEM-USA faith-based organization membership.
- 4. Seek out best practices and share them with the existing membership to provide tools and resources to encourage, build, and support community level partnerships between faith-based organizations and the emergency management community. Ex:
 - i. <u>Georgia Emergency Management Initiative</u>: Praise and Preparedness: http://www.praise.ga.gov/. This program encourages congregations toward personal preparedness as well as becoming involved in community emergency disaster relief efforts, feeding and sheltering programs.
 - ii. MGT 405 Mobilizing Faith-Based Community Organizations in Preparing for Disasters: This 8-hour, planning and management-level course trains faith-based community organization (FBCO) representatives, management-level emergency managers, and first responders from small and rural communities to strategically mobilize and engage members of FBCOs, including religious charities, nonprofits such as the Salvation Army, the American Red Cross, churches (both affiliated and unaffiliated), temples, synagogues, mosques, and NGOs etc., in a reciprocal approach to disaster planning that is integrated into current local and statewide emergency management efforts.
- 5. Collaborate with federal, state, local and independent organizations whose initiatives and missions are aimed at encouraging relationships with faith-based organizations. Work with these partners to create a "one-voice" national message regarding the importance of engaging and supporting faith-based organizations.
 - Department of Homeland Security Center for Faith-Based & Neighborhood Partnerships: Serve as connecting point to the White House Office of Faith-Based & Neighborhood Partnerships. (Director Rev. Jamie Johnson).
