A Look Back at 2013 – State of Kansas

Kansas Adjutant General 2013 Annual Report

Over the last three years, the Kansas Division of Emergency Management (KDEM) and Kansas Homeland Security (KSHLS) have experienced a reduction in federal funding of approximately 65 percent. Deputy Director Morgan has been working with the Office of the Governor, the National Conference of State Legislatures, the Council of State Governments and various other persons and groups to develop a sustainability strategy for the KSHLS and the KDEM. The purpose of the information is to position both KSHLS and KDEM to withstand anticipated budgetary difficulties in the near future. The strategy will provide for the long-term viability of both divisions.

Due to budgetary constraints, a self-assessment tool has been developed that will help schools with a vulnerability assessment of safety, preparedness and security issues. The Comprehensive Resource Management and Credentialing System (CRMCS) currently have approximately 35,400 personnel and 3,600 pieces of equipment entered from state and local level. Integration between the Kansas Driver's License System and Resource Manager Web was finalized in September 2013, allowing the first responder indicator to be printed on Kansas driver's licenses. The LEOPard mapping support application was released in 2013 and provides GIS capability to assist in county emergency operations planning.

In planning, the update of the Kansas Response Plan which serves as the state's emergency operations plan was completed; the update of the State Hazard Mitigation Plan (SHMP) that identifies state hazards, risks associated with those hazards and specific actions which can reduce risk was also completed. This is the first time that the SHMP was written in a regional format, thereby enhancing the regional mitigation planning initiative.

A COOP tabletop exercise in July included 36 participants from eight state agencies to test the agencies' mission-essential functions, staff notification procedures in an emergency and alternate facility plans. An Alternate Site Drill in August challenged state agency participants to physically visit their alternate work sites and complete a checklist evaluating the capabilities and functions that could be supported at the site. The exercise included more than 50 people from 12 state agencies.

Additionally, the regional hazard mitigation planning initiative involving the counties has been implemented and is 27 percent complete. Lastly, the state Threat and Hazard Identification and Risk Analysis (THIRA) was also updated and identifies capability targets for each core capability and estimated resources required to meet high priority capability targets.

Training staff facilitated the delivery or attendance of 23 courses from the National Domestic Preparedness Consortium. A total of 121 FEMA/National Incident Management System emergency management courses were provided to 2,690 participants. In 2013, the KDEM Volunteer Training Cadre grew to 65 members with 45 attending the Instructor Cadre Meeting and Professional Development Training.

Crisis City officially opened Oct. 1, 2009, and serves as a multiuse, fully-functional training complex for local, state and federal responders, emergency management officials, public and private industry safety professionals, and military operations in support of civil authorities.

A site survey conducted by National Guard Bureau officials has designated the Kansas Army National Guard Weapons Range and Crisis City as one of 10 national chemical, biological, radiological, nuclear and explosive training facilities in the country. Training venues at Crisis City have increased to 13 venues available for scheduling and use with two others in planning stages.

For federal fiscal year 2013, there were 21 projects supported in 2013. There were two major regional projects—a 12-county commodity flow study in the northeast and a three-county regional emergency operations plan update. One project was awarded to the Kansas Fire and Rescue Training Institute to offer classes around the state in the areas of hazmat on-scene incident commander and LP gas ammonia, and ethanol emergencies.

EMAP Accreditation



2013 marked the year the State of Kansas joined lowa, Missouri and Nebraska as an Emergency Management Accreditation Program (EMAP) participant.

EMAP is an independent, non-profit organization, fostering excellence and accountability in emergency management and homeland security programs by establishing credible standards applied in a peer review accreditation process.

Emergency management departments, divisions or offices wishing to become accredited must follow a six step process that includes:


1) subscribing to EMAP that includes an EMAP Assessment Tool;

2) conducting a self-assessment using the tool to determine if existing programs are in compliance with the 63 EMAP standards with corrective activities and/ or additional reviews are needed and then submitted to EMAP for review; 3) an application is completed once the assessment has been completed and there is a desire to pursue accreditation;

4) the applicant is provided information on a proposed schedule for a team visit for an on-site assessment;

5) an EMAP Program Review Committee reviews team findings and documentation provided of compliance or non-compliance with recommended accreditation submitted to the EMAP Commission; and,

6) the EMAP Commission may grant full accredited status, conditional accreditation (deficiencies can be addressed in nine months) or denial for accreditation with reasons for the decision.



A Look Back at 2013 – State of Iowa Submitted by Lucinda Robertson, HSEMD PIO

The year 2013 was a busy and productive one for the lowa Homeland Security and Emergency Management Department (HSEMD), in great part due to the four Presidential Disaster Declarations received by the State of lowa. Iowa's weather woes began in April with a severe winter storm and severe storms and flooding, followed by tornadoes, severe storms and flooding in May and June.



All four of Iowa's Presidential Disaster Declarations provided Public Assistance funding to the declared counties. More than \$45 million in damage is estimated to be eligible under the federal Public Assistance Program for the four disasters. The 2013 disasters also brought to the state an estimated \$6.8 million in hazard mitigation funding for projects statewide to minimize the impact of future disasters.

lowa's state-funded Flood Mitigation Board began its work to create a flood mitigation program in 2013. This program allows certain governmental entities to submit flood mitigation projects to the board for review and possible approval of funding. The funding will come from either sales tax increments or funds appropriated by the General Assembly. In December 2013, the board approved funding for flood mitigation projects for six communities, totaling \$877 million with the state providing \$390 million via the sales tax increment. The board will consider applications for funding through the end of 2015. The board was created by the Iowa General Assembly and signed into law by the governor in 2012. HSEMD's director chairs this board and department staff is closely involved in assisting the board with its work. Over the past year HSEMD took action to build response capability at the local level. Recognizing that all disasters start as local events, the department purchased and prepositioned pumps and generators throughout the state. Prepositioning of 31 pumps and 17 generators will enable quick assess when these resources are needed. Another area where HSEMD is assisting local government is emergency mass notification. A survey conducted by the department showed that 52 counties spent more than \$600,000 per year for their current mass notification systems, while 46 counties used a free system or had no system at all. In 2013, HSEMD issued a request for proposal for a statewide mass notification system with the goal of providing greater access to this type of tool. In 2014, HSEMD will pursue implementation of an emergency mass notification system to create a more efficient system at a reduced cost.

HSEMD also began working with local emergency managers in 2013 to conduct an assessment of current local and state capabilities to carry out emergency management functions. A group of subject matter experts assessed current capabilities in 31 areas. This year, the group involved in this project will identify gaps in capabilities and propose ways to fill those gaps. The goal is to build capabilities from the ground up, and HSEMD has committed \$400,000 to this effort.

HSEMD continued its work in 2013 to upgrade the state's wireless 9-1-1 system using leading-edge technology. Iowa is one of the first states to complete a statewide upgrade of its wireless 9-1-1 network to an Internet Protocol (IP)-based system, which is more robust and capable of handling new messaging technology. HSEMD is continuing to work with the state's public safety answering points over the next two years as they upgrade their call-taking equipment and with wireless service providers as they work to utilize this technology. When completed, this project will allow lowans to contact 9-1-1 using IP-based text, video and picture messaging. A great many lowans use communication devices that offer text, video and picture messaging capabilities and we must be able to

Iowa Homeland Security and Emergency Management Department (HSEMD)



Director: Mark Schouten The Homeland Security and Emergency Management Department has been working to make lowa more prepared for disasters since it began as the State Civil Defense Agency in 1965. The focus of emergency management and the hazards faced by lowans may have changed in some ways since that time, but what hasn't changed is our commitment to making our state more prepared for any emergency or disaster.

Following the terrorist attacks of September 11, 2001, the Department was directed by the Governor to coordinate Iowa's homeland security efforts. While this broadened our mission, our underlying priority of ensuring Iowa is prepared and ready to respond to any disaster drives all we do.

Iowa Emergency Management Association (IEMA)



The IEMA Executive Committee consists of a President, Vice President, Past President, Secretary and Treasurer. In addition, each of Iowa's six emergency management districts each elects a person to represent their district on the Executive Committee.

President: A.J. Mumm The Iowa Emergency Managers Association (IEMA) recently revamped an education program for local emergency managers. The IEMA Executive Committee established a working group to create version 3.0 of an education program.

The resulting Emergency Management Program Development Course now has a multi -method approach that includes classroom lecture, mentorship, and practical experience demonstrated through a task to design a program that focused on competency over compliancy. The work group met several times over the past year to update the curriculum, develop presentation materials, create instructor guides, and craft task books for each module. The course is taught jointly by local emergency managers from Iowa as well as staff from the Iowa HSEMD.



Kansas Division of Emergency Management (KDEM)

The Division of Emergency Management is the arm of the Adjutant General's Department that provides mitigation advocacy, planning requirements and guidance, response coordination, and administration of recovery programs for the civil sector of the State, regardless of the type of hazards.

Each county is required to maintain a disaster agency responsible for emergency preparedness and coordination of response to disasters.

The State and local governments work together to provide training to local emergency management and response personnel, along with periodic exercises to test the State and local emergency management systems.

Kansas Emergency Management Association (KEMA)

KEMA offers networking opportunities among local emergency managers as well as opportunities to interact with emergency management professionals, other affiliated individuals, governmental agencies, and interested private groups.

In response to a growing movement nationwide to provide for methods of professional certification of emergency managers, KEMA developed a certification program that would increase the visibility and scope of emergency managers' positions and the commensurate requirements to ensure that some mechanism was in place to evaluate persons who occupied these positions.

State of Missouri Emergency Management Agency (SEMA)

The State Emergency Management Agency, a division of the Department of Public Safety, is the state of Missouri's coordinating agency for disaster response.

The State Emergency Management Agency's mission is to protect the lives and property of all Missourians when major disasters threaten public safety in any city, county or region of Missouri. SEMA works with other state departments and agencies, and the federal and local governments to ensure coordinated disaster response.

The agency consists of almost 50 full-time employees in five branches: Executive; Administrative and Fiscal; Logistics and Resources Management; Operations, Training and Exercise; and, Planning and Disaster Recovery.

Missouri Emergency Preparedness Association (MEPA)

The Association has been in existence since the 1950's and was formed by innovative local Civil Defense directors. Their mission, to help their fellow colleagues communicate to all the citizens throughout the state, better ways to prepare for disasters to be a collective group in getting that message to the citizens, and encourage the development and growth of the profession overall. The association still looks to provide these tasks and more through a new inspiring, group of individuals, enriched on innovating ways and educating means.

Nebraska Emergency Management Agency (NEMA)

Assistant Director: Al Berndt The Nebraska Emergency Management Agency (NEMA) is part of the Military Department. The state's Adjutant General, Major General Daryl Bohac, serves as the director of the agency as well as the commanding officer of the Army and Air National Guard.

The agency is located in a bunker built in the 1960s during the height of the Cold War. It was intended to serve as Nebraska's government headquarters if nuclear confrontation was likely. The agency headquarters now serves as the nerve center for emergency management. NEMA is a small agency with less than 40 full-time and parttime employees.

Nebraska Association of Emergency Management (NAEM)



President: Lynn Marshall The purpose of NAEM is to serve the emergency managers throughout Nebraska by: Encouraging the development of disaster resistant communizes to reduce the effect of disasters on life and property; providing a forum for creative and innovative problemsolving on emergency management issues; fostering informed decision-making on public policy in the emergency management arena; providing means of networking opportunities between individuals involved in the many different facades of emergency management and Homeland Security; and, development and delivery of educational programs to the public.

The Nebraska Association of Emergency Management (NAEM) is governed by the following offices: President, Vice President, Secretary, Treasurer and 5 Directors that represent the Nebraska Association of County Officials (NACO) districts. NAEM has four membership levels: Professional, Associate, Departmental, and Retired. We are also considering an additional level for Emergency Management students who are enrolled in an accredited EM program. The Departmental membership is offered for larger agencies that have multiple EM staff and or EM Liaisons in their organization. We are currently coming off the NACO Conference in December and are currently rolling out some of the agenda for 2014 Annual conference April 2-4, 2014.

Another project we have on the calendar is our Statewide Severe Weather Poster Contest which is sponsored by NAEM, NEMA, and National Weather Service. We offer this contest to our fourth graders statewide, and the top 4 winners are honored at the State Capitol during the Governors' Proclamation kicking off the Statewide Severe Weather Awareness week March 24 – 28. The top winners earn a monetary gift for their efforts, ranging from \$125 for 1st, \$100 for 2nd, \$75 for 3rd and \$50 for fourth. Their award winning posters also are matted and framed as part of contest.
