### **IAEM** presents EMvision Talks








# IAEM-USA and NEMA Release Joint Report: EMPG Grants Providing Returns on a Nation's Investment. April 3, 2015

IAEM-USA and NEMA have released a joint report, "Emergency Management Performance Grants Providing Returns on a Nation's Investment, 2015 Edition." NEMA surveyed the state directors and IAEM-USA surveyed the local government emergency managers, and a joint report was prepared. IAEM-USA very much appreciates the 1,159 local government emergency managers who completed the survey, but notes that much more is being accomplished with EMPG funds than is noted in the report, since this number represents less than a third of the local jurisdictions estimated to be eligible for EMPG funding. We particularly appreciated the success stories and wish we could have printed them all.

## **IAEM Think Tank Initiated In (Region 8!) DENVER**

In February, the IAEM was proud to launch their first IAEM Think Tank. These are web-based conference calls based on the FEMA Think Tank calls which Rich Serino facilitated when he was the Deputy Administrator,

IAEM's Think Tank goal is to launch a venue to engage our partners, promote innovation, and facilitate discussions in the field of emergency management.

The topic of the first IAEM Think Tank call was focused on the floods that occurred in Colorado in 2013 and how the communities mitigated, prepared, responded, and recovered from these events. Representatives from Boulder OEM, Fort Collins OEM, El Paso County OEM, Jamestown, and the State of Colorado were guest presenters.
